## **ITEMS OF INTEREST**

1. <u>City-funded Temporary and Emergency Shelter Performance</u>: The City posts weekly information about its Temporary and Emergency Shelter locations including current census, number of available beds, and exits to housing. **This information can be found at:** <a href="https://cms.tacoma.gov/ncs/weeklydataupdate.pdf">https://cms.tacoma.gov/ncs/weeklydataupdate.pdf</a> and is updated weekly.

Pierce County Human Services also uses the Homeless Management Information System to report daily availability throughout Pierce County. This information can be found at: <a href="https://www.piercecountywa.gov/8220/Homeless-Emergency-Shelter-Availability">https://www.piercecountywa.gov/8220/Homeless-Emergency-Shelter-Availability</a> and shows the available beds open at shelters and is updated Monday - Friday by 10:00 a.m.

- 2. HEAL TEAM Engagement Dashboard Update: To reflect Ordinance 29064, passed by Council on October 21, 2025, staff has been working to update Homeless Engagement Alternative Liaison (HEAL) Engagement Dashboard's map. This dashboard provides Tacoma residents with a transparent, accessible way to determine whether a particular encampment falls within the City's prohibited areas. The dashboard includes outreach data provided by the HEAL Team, 311 requests related to homelessness, and calls for emergency services. - 3. <u>Encampment Outreach:</u> For the week of **October 27 31, 2025**, the HEAL team visited **23 locations**. This resulted in **50 (19 new, and 31 repeat)** individuals contacted and referred to community services; 4 individuals accepted shelter placement. This information can be found at: <u>HEAL Team Engagement Dashboard | Tacoma Open Data.</u>
- 4. <u>Inclement Weather Response</u>: For the 2025-2026 cold weather season, the City of Tacoma continues to work with community partners to ensure that unsheltered individuals have access to water, warming supplies, information about warming centers, and sheltering throughout the city.

Altheimer Memorial Church (1121 S Altheimer Street) will begin operating a seasonal shelter (32 beds) starting November 15, 2025. They are expected to operate the shelter through March 2026. Referrals will come from multiple teams including the City's Homeless Engagement Alternative Liaison (HEAL)Team, outreach providers, and other emergency shelters that have reached capacity.

For an acute inclement weather event (when the forecast is for 35 degrees with wind/rain or 32 degrees and colder):

- o Valeo Vocation (415 South 13th Street, Tacoma, WA 98402): Providing 20 overflow beds for young adults 18-24 years of age at the Beacon Young Adult Shelter.
- o Saint Vincent DePaul ( 4009 South 56th Street, Tacoma, WA 98409): Expanding motel shelter capacity for up to 20 households.

Additionally, the City has worked to ensured that there are sufficient supplies available throughout the city including at City Libraries and these additional locations:

- Stability Site: 1423 Puyallup Ave, Tacoma, WA 98421, 7 days a week, 8:00 a.m.- 5:00 p.m.
- Saint Vincent DePaul's Community Resource Center (for adults): 4009 South 56th Street, Tacoma, WA 98409, operating 7 days a week during inclement weather response, 9:30am - 7:00 p.m.
- Saint Vincent De Paul's Family Community Resource Center (for families): 505 South Tacoma Way, Tacoma WA 98402, operating 7 days a week during inclement weather response, 9:30am – 4:00 p.m.
- o Common Good First Methodist Church: 621 South Tacoma, Tacoma WA, 98402, open Monday, Wednesday, and Friday, 10:00 a.m. 4:00 p.m.

Pierce County has shared the information in the post below regarding how to access or volunteer at food banks in our local area. Pierce Transit is allowing all federal employees who present their government-issued ID to ride all Pierce Transit services, including Bus, SHUTTLE paratransit, Runner, and Rideshare, for free during the federal government shutdown. Tacoma Public Utilities and the Tacoma Environmental Services Department offer a Bill Credit Assistance Plan and a Discount Rate Program to support those facing financial challenges. - The Tacoma Community House helps individuals gain the skills they need to transition out of poverty, navigate a new culture, and find personal and professional success. Council Members John Hines, Kristina Walker, and Sarah Rumbaugh toured the facility, along with their REACH Center serving youth ages 16-24, to learn more about the programs and services they offer. While there, they met with Executive Director Aimee Khuu and students from all over the world who were on site improving their English language skills. - o Tree success story! Our Public Works and Environmental Services departments recently worked together to save two massive and mature walnut trees that were adjacent to a sidewalk replacement project at the <a href="Tacoma Fire Department">Tacoma Fire Department</a> Communications building (415 Tacoma Ave. South). Our Urban Forestry Program Manager worked with the Project Engineer to make sure these trees could survive construction, and through proactive planning, were able to protect the roots while building a wider sidewalk to accommodate heavier foot traffic. As a bonus, Council Members Kristina Walker and John Hines planted three new trees on the site that will one day be as large as the walnut trees they're planted alongside.







We ask for your support for a Council Contingency Fund expenditure in the amount of \$25,000 to sponsor the Year of Belonging Initiative, administered by the Tacoma Community House.

## **LEGISLATIVE INTENT**

**Council Contingency Fund Request:** The Year of Belonging initiative is a series of events, community convenings, and discussions, as well as a communications campaign, aimed at proactively promoting inclusion and a welcoming environment in Tacoma. The initiative helps advance connection, understanding, and collective growth across the city, with a special focus on celebrating and fostering unity with our immigrant and refugee community, BIPOC community, and LGBTQIA+ community. The Year of Belonging launched during Welcoming Week in 2025 (September 12-21) and extends through Welcoming Week in 2026.

- Mayor Victoria Woodards launched this initiative in partnership with the Tacoma Public Library and Tacoma Community House.<sup>12</sup> The Tacoma Community House, a nationally recognized non-profit serving immigrant and refugee communities as well as long-time residents seeking education, support, and pathways out of poverty, will continue administrating the initiative.
- There have already been three successful events under the umbrella of the Year of Belonging including a community convening and discussion, as well as an educational symposium and lunch hosted and supported by Tacoma Community House. This year's Tacoma Reads program was also in partnership with the Year of Belonging, featuring an interview with author Valerie Kaur and a large community event produced by the Tacoma Public Library.<sup>3</sup>

If approved, this sponsorship would support ongoing costs for the initiative, such as the production of free community events that are open to the public, advertising and program printing, invitations

and mailers, the production of an initiative website, and resources for community members served by Tacoma Community House.

The City's sponsorship would be acknowledged by using the City of Tacoma logo on promotional materials. In addition, the Year of Belonging initiative would help to advance several of Tacoma's strategic goals and plans. Most importantly, Tacoma is a member of the Welcoming Cities and Counties Initiative, which aims to encourage the creation of more welcoming, immigrant-friendly environments that maximize opportunities for economic growth and cultural vitality.<sup>4</sup> In addition, the Community Safety Action Strategy and the Tacoma 2025 Framework advocate for fostering inclusive communities.<sup>56</sup>

## **FUNDING REQUESTED**: \$25,000

## **COMMUNITY ENGAGEMENT/ (CUSTOMER RESEARCH):**

Tacoma Community House has been independently convening, producing, and marketing the Year of Belonging and completing extensive outreach to the community they serve as well, as the general public. Tacoma Public Library has also been promoting events and has completed the initial production of an initiative website that provides users access to information as well as a calendar of initiative events. This funding will support the ongoing work of Tacoma Community House in the administration of this initiative and allow for broader outreach and communications strategy.

## **2025 STRATEGIC PRIORITIES:**

## **Equity and Accessibility:**

The Year of Belonging Initiative is focused on our immigrant and refugee community, our BIPOC community, our LGBTQIA + community and increasing inclusion and positive well-being for these Tacoma residents. The initiative seeks to foster inclusivity for all in alignment with City values as well as foster community connection and unity.

## **Civic Engagement:** *Equity Index Score*: Moderate Opportunity

Increase the number of residents who participate civically through volunteering and voting. Increase the percentage of residents who believe they are able to have a positive impact on the community and express trust in the public institutions in Tacoma.

**DATE:** November 5, 2025

I ask for your support for a Resolution directing the City Manager to create a centralized grant tracking system and to require Council approval for certain grants.

## **LEGISLATIVE INTENT:**

The City of Tacoma actively seeks grant funding for projects in alignment with Council priorities and community need. The current process for accepting grants includes reviews from staff such as Legal, Finance, and department directors. City staff can apply for, receive, and enter into contracts for grants without the public or the City Council's direct knowledge. While staff's efforts are to advance Council priorities, there is not a formal approval mechanism to ensure grant application, grant acceptance and grant-funded programs meet Council and community expectations. The grant-funded programs may also be structured to require local resources to match grant amounts or that the City continue to support grant funded programs after the grant funds are exhausted. This may place additional strain on resources, and/or may create disappointment in community if the grant programs are unable to be continued after grant funding is exhausted.

This resolution directs the City Manager to create a centralized grant tracking system to monitor all grants applied for and received by the City.

The resolution further directs the City Manager to create an approval process for receiving grants, incorporating the following guidelines:

- Require City Council approval, via consent agenda, for the City to accept grants which:
  - Are over \$100,000 and fund operations, or that have the potential to require or create expectation of continued funding after the life of the grant.
  - Are over \$500,000 and fund capital projects, and as required by the funding agency.
- In the case of a tight timeline for accepting a grant, the City Manager should have authority to approve acceptance, followed by confirmation by the full City Council at the next available Council meeting. Emergency approval is contingent on the ability to cancel or rescind acceptance should it not be approved by Council.
- In the case of recurring grants that the City receives annually, the initial Council approval can authorize future approvals. If the intent of the grant or purpose of the funds change, it should return to Council for reapproval.

• In the case of grants for Tacoma Public Utilities, the approval process shall be completed through the Tacoma Public Utilities Board following the guidelines above. For grants with timing issues, authorizations may be completed by the Director of Utilities.

The City Council grant approval process should be implemented by June 30, 2026.

DESIRED RESOLUTION DATE: December 2, 2025

## **COMMUNITY ENGAGEMENT/ (CUSTOMER RESEARCH):**

The City Council has repeatedly heard from community members regarding grant funding for programs that they did not know about or expect. This step would build belief and trust with community by making the process of approving grants more transparent and putting the ultimate decision in the hands of the elected City Council.

## **2025 STRATEGIC PRIORITIES:**

## **Equity and Accessibility:**

The City of Tacoma relies on grant funding for a broad range of City services, including funding infrastructure projects, health and human services programs, and housing. All of these topics have equity and accessibility impacts.

**Civic Engagement:** *Equity Index Score*: Moderate Opportunity

Increase the percentage of residents who believe they are able to have a positive impact on the community and express trust in the public institutions in Tacoma.

Explain how your legislation will affect the selected indicator(s)?

Creating a more transparent process for approving grants would allow community to raise equity and accessibility concerns regarding grants before the City enters into contracts that commit us to deliverables. This provides more opportunities for public to engage with topics and daylight unforeseen impacts on all communities in Tacoma.

The City Manager should bring the developed grant approval and tracking process to GPFC for discussion prior to implementation of this policy. The City Manager should implement any fiscal policies and procedures related to grants approval and tracking by June 30, 2026.

## SPONSOR RECOMMENDATION:

Sponsors recommend the City Council address the belief and trust gap in how the City applies to and accepts grants by adding in this transparency mechanism that clarifies the City Council is ultimately responsible for determining whether the City will accept grant funding.

## FISCAL IMPACT:

Implementation of this policy will require upfront cost to create or purchase the grant management system, and ongoing costs associated with maintaining the grant management system and department staff requirements to ensure departments compliance with grant tracking approval and tracking, prepare documents and standard procedures for grant applications, acceptance and tracking, review with Legal, get uploaded in Legistar, attend Council meetings to present resolutions and other work related to this initiative.
