### SUMMARY AND PURPOSE:

A resolution authorizing the execution of an interlocal agreement with the Washington State Employment Security Department (ESD) allowing authorized City staff to receive confidential unemployment insurance data in the records of ESD that is collected from employers and individuals for the administration of the state unemployment insurance program for a period to start on the date of contract execution through November 30, 2028.

### **BACKGROUND:**

This Department's Recommendation is Based On: To effectively administer the City's tax and license program, the Tax & License Division relies on several resources to discover business activity in the City and verify the amount of local Business & Occupation tax paid to the City by a business. Being able to access ESD data provides another avenue for discovery of businesses and verification of payroll in the City.
