RECOMMENDATION SUMMARY:

The Tacoma Venues and Events (TVE) Department requests approval to increase contract CW2272006, to Northwest Industrial Staffing, Inc., Kent, WA, by \$300,000, plus applicable taxes, budgeted from the Dome fund 4180 and Convention Center fund 4165, for temporary janitorial and maintenance services. This increase will bring the contract to a projected total of \$790,000, plus applicable taxes.

STRATEGIC POLICY PRIORITY:

- Foster a vibrant and diverse economy with good jobs for all Tacoma residents.
- Cultivate a vibrant cultural sector that fosters a creative, cohesive community.

Northwest Industrial Staffing, Inc. provides temporary janitorial and maintenance services for the Tacoma Dome and Greater Tacoma Convention Center. This work employs hundreds of local and regional residents and enables TVE to provide clean and safe events in support of creating a vibrant cultural sector in the community.

BACKGROUND: On February 1, 2025, TVE entered into a contract with Northwest Industrial Staffing, Inc. for provisions of temporary janitorial and maintenance services for the Tacoma Dome and Greater Tacoma Convention Center, with a termination date of February 1, 2026, and an initial compensation not to exceed (NTE) the amount of \$490,000.

ISSUE: The current agreement ends on February 1, 2026. Due to increased event activity and service requirements at the Tacoma Dome and Greater Tacoma Convention Center, existing contract funds are insufficient to cover the necessary on-call janitorial and maintenance services through the contract term. This increase is critical to the appearance, functionality, and safety at the Tacoma Dome and Greater Tacoma Convention Center, ensuring TVE can meet contractual obligations and maintain the cleanliness standards expected by clients and patrons during this high-demand period.

ALTERNATIVES: The contract could not be increased, resulting in extreme disruption to events at the Tacoma Dome and Greater Tacoma Convention Center.

Request for Proposals Specification No. PF24-0131F was opened July 17, 2024. Three companies were invited to bid in addition to normal advertising of the project. Four submittals were received, with Northwest Industrial Staffing, Inc. receiving the highest scoring.
