a. Youth Seat Consideration

Linda Foster, Policy Analyst in the City Manager's Office, presented an overview of Council member Rumbaugh's proposal for a youth seat on several City Committee, Boards, and Commissions, including the Tacoma Arts Commission. She reviewed the history, purpose, and suggested structure for a youth seat. Commissioners asked questions and provided comments.

Council member Rumbaugh is asking the Commission to decide whether they would like to be included in the proposal for a youth seat. Commissioners Dean, Gilmore, Hoppe, Kula, Ng, Nunn, and Sanchez volunteered to discuss the option to add a youth seat on the Commission.
