AMENDMENT NO. 4 TO AGREEMENT

THIS AMENDMENT is made and entered into effective as of November 1, 2025 ("Effective Date"), by and between the CITY OF TACOMA, a municipal corporation of the State of Washington (hereinafter called the "CITY") and **TACOMA COMMUNITY REDEVELOPMENT AUTHORITY (TCRA)** (subsequently referred to as the "Sub-recipient").

WHEREAS CITY and Sub-recipient entered into an Affordable Housing Fund Agreement, with an effective date of December 1, 2021 (the "Agreement") for the purpose of carrying out the City's RESOLUTION NO. 40527 relating to affordable housing, as is more specifically described in Exhibit B ("Scope of Work") to the Agreement in the not to exceed amount of \$3,856,000 to be paid in accordance with Exhibit C ("Compensation and Financial Requirements") to the Agreement and with a termination date of December 1, 2031 and;

WHEREAS on November 1, 2022 the CITY and Sub-recipient executed Amendment 1 to the Agreement in order to increase the compensation under the Agreement by \$3,852,421 from \$3,856,000 for a new not to exceed amount of \$7,708,421 and;

WHEREAS on November 1, 2023 the CITY and Sub-recipient executed Amendment 2 to the Agreement in order to increase the compensation under the Agreement by \$13,421,349 from \$7,708,421 for a new not to exceed amount of \$21,129,770 and;

WHEREAS on November 1, 2024 the CITY and Sub-recipient executed Amendment 3 to the Agreement in order to increase the compensation under the Agreement and adjust previous compensation amounts to align with actual project funding commitments and;

WHEREAS the actual compensation amounts were adjusted as follows: Original agreement-\$3,536,218.77; Amendment 1 added \$3,368,119; Amendment 2 added \$13,421,349; and Amendment 3 added \$6,949,311 for a total Agreement value of \$27,274,997.77.

WHEREAS the CITY and Sub-recipient desire to amend the Agreement to increase the compensation under the Contract by \$10,897,544.

NOW, THEREFORE, in consideration of the mutual promises and obligations hereinafter set forth, the parties agree as follows:

 Section 2. Consideration on Pg. 1 of the Agreement is hereby amended to read as follows: "The maximum consideration for this Agreement shall not exceed \$38,172,541.77 (Thirty-Eight Million, One Hundred Seventy-Two Thousand, Five Hundred Forty-One and 77/100 Dollars)."
