**SUMMARY:**

Authorizing the appropriate City officials to execute a 12-Year Multifamily Housing Property Tax Exemption Agreement with Journey Points Homes LLC for the development of six multifamily affordable and market-rate rental units at 3010 S PUGET SOUND AVE, in a Residential Target Area which allows for MFTE usage.

**BACKGROUND**

Journey Points Homes LLC is proposing to develop six new affordable and market rate rental units as described in Exhibit “A” to the Resolution. The housing units are as described in the chart below.

The Project will also include four parking spots. The project will be forwarded to the Pierce County Treasurer Assessor for the 12-Year Multifamily Housing Property Tax Exemption after the project complies with all City of Tacoma building codes, processes and procedures and receives a valid temporary or permanent certificate of occupancy from the City. The Community and Economic Development Department has determined that the proposed project has all the necessary qualifications for the 12-Year Multifamily Housing Property Tax Exemption. Journey



Points Homes LLC will enter into an agreement prepared by the City to develop the site as described in the plans on file with the City.

**ISSUE:**

This action would approve the tax exemption through the attached proposed agreement.

**COMMUNITY ENGAGEMENT/ (CUSTOMER RESEARCH):** March 2025 Outreach to multifamily properties indicate that Tacoma continues to have only a seven percent 7% vacancy rate in rental housing, which indicates there is still a critical housing need in Tacoma. New projects coming on line are quickly leased which also indicates that demand is not slowing. As we add additional units, pressure on the market should be relieved and prices should reflect less upward pressure.

**2026 STRATEGIC PRIORITIES:**

**Equity and Accessibility:** *Equity Index Score: Low*

These housing units will create more overall housing and more affordable housing units in Tacoma and they ensure that affordability is being created throughout the City of Tacoma and not just in certain areas. Creating market rate and affordable units provides accessibility to jobs, transit and other amenities in that district.

**Economy/Workforce:** *Equity Index Score: Low*

Increase the percentage of people relocating to the city and affordability of housing compared to neighboring jurisdictions.

**Livability:** *Equity Index Score: Very Low*

Decrease the percentage of individuals who are spending more than 45% of income on housing and transportation costs.

**STAFF RECOMMENDATION:**



Staff has reviewed the application and has determined that the proposed project qualifies for the 12-Year Multifamily Housing Property Tax Exemption. Staff recommends the Council approve the resolution.

**FISCAL IMPACT:**

The value of the land would continue to be taxed throughout the exemption period. The additional greater economic impact to Tacoma from adding to the population base is estimated through sales tax generation. The projected assessed value of the completed project, the projected property taxes to be exempt and the projected increase in sales tax are listed in the table below:

\*\*\* The projected *Sales Tax Generated from Construction* is estimated by multiplying the construction costs by the sales tax rate.
