#### **SUMMARY AND PURPOSE:**

A resolution authorizing execution of a Letter of Agreement as negotiated with the Tacoma Police Union, Local 6, Commissioned Unit, for the continuation of employee health and welfare benefits.

#### **BACKGROUND:**

The resolution authorizes execution of a of a Letter of Agreement (LOA) as negotiated with the Tacoma Police Union, Local 6, Commissioned Unit. The Letter of agreement provides for the continuation of employee health and welfare benefits. The agreement currently covers approximately 308 budgeted, full-time equivalent (FTE) positions.

The City will continue to pay the full premium cost for dental and vision insurance for eligible full-time employees, and employee premium contributions toward medical insurance coverage remains unchanged. Plan design changes include the incorporation of various state and federal mandates as well as enhanced care management services under the Regence BlueShield health plans; and also includes language regarding enhancements implemented to the City of Tacoma Wellness Program.
