



ORDINANCE NO. 29112

1 AN ORDINANCE relating to pay and compensation; amending Chapter 1.12 of the
 2 Tacoma Municipal Code, relating to the Compensation Plan, to implement
 3 changes to non-represented classifications due to organizational need, to
 4 include rates of pay and classification changes to reflect the organizational
 5 structure.
